The loss of KCA's vital contributions would severely impact our ability to provide essential food to those in need. As many of our most vulnerable residents in the Newlands, Paparangi, Woodridge, and Grenada Village communities rely on our foodbank to make ends meet, the closure of our foodbank would leave them without a critical lifeline. The consequences of losing KCA's support would be felt deeply by those who depend on us.
